### Qualifications

- Applicants must be graduating seniors from **South Jefferson Central School** or **Pulaski Academy and Central School**. Students who attended career and technical programs at BOCES are *strongly* encouraged to apply.
- Applicants must be **full-time undergraduate** students. Graduate study is **not** funded.
- Students who will be attending **technical** schools are eligible to apply.
- Applications are accepted from **high school seniors** for freshman year of college.
- This scholarship is a **one-year** award.

### Selection Criteria

Recipients of the Richard C. Jr. and Linda A. McNeely scholarship are chosen based on personal data and recommendations.

### Instructions

Read all materials completely so you understand what is available, the criteria, and what is expected of you. **Materials must be submitted as a complete packet in order to be considered for a scholarship.** Packets must be received by April 30, 2019 – packets postmarked after April 30<sup>th</sup> will not be considered.
