

### Scholarship Rule and Application

*Submit by July 31 or December 31 (limit 1 scholarship per year per person)*

#### **Mission/Purpose:**

Through this scholarship program, The Women's Council of Realtors Tri-County NY Network aims to raise the level of knowledge, professionalism and leadership of REALTORS<sup>®</sup> in the communities we serve.

#### **Eligibility:**

If you have been a member of WCR Tri-County Network for at least a year, are licensed and actively practicing in New York State and hold a REALTOR<sup>®</sup> membership in New York State, you are eligible.

#### **Application Requirements:**

\_\_\_\_ Completed applications must be submitted by July 31<sup>st</sup> for October awards and by December 31<sup>st</sup> for February awards. Incomplete applications will not be considered

\_\_\_\_ One letter of recommendation supporting the applicant must be included and must be signed and dated within the previous three months. Recommendations may be from the broker or manager of the firm with which the applicant is associated; from someone else familiar with the applicant professionally (such as a local board officer, a community or civic organization leader or other professional).

\_\_\_\_ You must attach a letter explaining your motivation for applying (although scholarship awards are not based on need, you may address any existing financial hardship), your future goals relating to the use of the scholarship, how far you'd be willing to travel to a course and if you plan to maintain membership in WCR. A description of your community involvement, local board activities and any other information that might aid in the selection process may be included in your letter.

Awards are announced by the WCR Tri-County NY Board of Directors twice a year (in February and October). Recipient of scholarship will be giving a credit of \$250. Upon completion of class, recipient will need to provide a copy of certificate for reimbursement.
