George R. Davis Fund for Lowville

(A charitable fund of the Northern New York Community Foundation)

Introduction: The George R. Davis Community Fund was established to benefit the citizens of the Village and Town of Lowville. In the years ahead, this fund will help bring much needed resources to the community.

The Honorable George R. Davis passed away in February 2010 after living almost his entire life in Lowville, NY. Judge Davis, as he was known, served for 20 years as Lewis County Judge from 1962 to 1983. George was active in civic affairs throughout his lifetime with a particular interest in local history including the history of Lowville Academy where his father served as supervising principal for over 35 years. George's devotion to this community was extraordinary. One of George Davis' lasting legacies is this unique community fund.

Mr. Davis was a graduate of Lowville Academy (1935), Deerfield Academy (1936), Middlebury College (1940) and Syracuse Law School (1948). He enlisted in the Army and served in the Pacific Theatre during World War II attaining the rank of Captain. He served as Lewis County District Attorney after his return to Lowville and was eventually elected County Judge in 1962.

Mr. Davis had a life-long love for Lowville and its history. Following his retirement from the bench, he continued to pursue his interest in local history. He was Town Historian for 18 years. He served on the Board of the Lewis County Historical Society for many years and later as President. He wrote numerous articles about local history over the years. He served on the Lowville Rural Cemetery Board and worked for many summers restoring old cemeteries and gravestones. He was active in the Lowville Academy Alumni and Friends Association and a member of the Association for the Protection of the Adirondacks. Mr. Davis became the Academy's historian and served in 2008 as honorary chairperson of the district's 200th anniversary.

Mr. Davis was the first recipient of the Lewis County Peace Prize and the last surviving member of the Lowville Band. He was a member of the Lowville American Legion Post #162, Lowville Elks Lodge #1605, V.F.W. Lewis County Memorial Post #6912 and the Lowville Masonic Temple #134. He was a member of the First Presbyterian Church where he was ordained an Elder in 1964 and served as a Trustee.

Selection Committee – In Mr. Davis’s will, he named the following to the selection committee: Court Attorney/Clerk for the Lewis County Judge, Superintendent of Lowville Academy, Mayor of the Village of Lowville.

The fund committee will evaluate each grant request on its merits using the “greatest positive impact on the community” as the guiding criteria in making the award(s). Projects may be large or small up to a total of \$15,000 for 2020. The committee will make its final recommendations to the Northern New York Community Foundation’s Board of Directors in June 2020.

Grant Report – It is a requirement that grant recipients submit a grant report provided by the Northern New York Community Foundation by the completion of your project. An incomplete report may affect future funding requests.
